# 6. Use of Cookies and Similar Technologies

HyperHouse Technology AB uses cookies (small text files placed on your device) and similar technologies to provide our websites and online services and to help collect data.

The text in a cookie often consists of a string of numbers and letters that uniquely identifies your computer, but it can contain other information as well.

HyperHouse Technology AB uses cookies and similar technologies for several purposes, depending on the product, including:

#### Preferences and Settings

Settings that enable our website and services to operate correctly or that maintain your preferences over time may be stored on your device.

#### Authentication

When you sign into a website using your personal account, we store a unique ID number, and the time you signed in, in an encrypted cookie on your device. This cookie allows you to move from page to page within the site without having to sign in again on each page.

### Analytics

In order to provide our products, we use cookies and other identifiers to gather usage and performance data. For example, we use cookies to count the number of unique visitors to a web page or service and to develop other statistics about the operations of our products.

# 7. How to Control Cookies

#### Chrome

- From the Chrome menu in the top right corner of the browser, select Settings.
- At the bottom of the page, click Show advanced settings
- Under Privacy, select Content settings
- To manage cookie settings, check or uncheck the options under "Cookies".
- To view or remove individual cookies, click All cookies and site data... and hover the mouse over the entry. Select the X that appears next to the cookie to remove it.
- To delete all cookies, click All cookies and site data... and select Remove all.

Firefox

- From the Tools menu, select Options. If the menu bar is hidden, press Alt to make it visible.
- At the top of the window that appears, click Privacy and follow the onscreen instructions.

#### Internet Explorer

• From the Tools menu, or the Tools drop-down at the upper right, select Internet Options and follow the onscreen instructions.

Safari

- In Safari, from the Safari menu, select Preferences....
- In the Safari preferences window, click Security and follow the onscreen instructions.
