# End User License Agreement HyperHouse Technology AB

This End-User License Agreement ("EULA") is a legal agreement between You (either an individual, a legal entity or any affiliated companies or other entities) and *HyperHouse Technology AB* as the licensor, ("Licensor")

## 1. General conditions

Please read this End-User License Agreement ("Agreement") carefully before installing and using the Software. By downloading or using the Application, you are agreeing to be bound by the terms and conditions of this Agreement. If you do not agree to the terms of this Agreement, do not download or use the Application. If you do not agree with these terms, you are obliged to remove all copies of the Software.

Installation or use of the software also operates as your consent to the transmission of certain standard computer information during license validation and automatic download and installation of certain updates.

# 2. Scope of the Agreement

This agreement applies to all software developed by *HyperHouse Technology AB*. This Agreement governs your initial purchase as well as any future purchases made by you that reference this Agreement.

# 3. Scope of License

The software is licensed, not sold. This agreement only gives you some rights to use the software. HyperHouse Technology AB reserves all other rights. You may not:

- work around any technical limitations in the software;
- reverse engineer, decompile or disassemble the software, except and only to the extent that applicable law expressly permits, despite this limitation;
- make more copies of the software than specified in this agreement or allowed by applicable law, despite this limitation;
- publish the software for others to copy;
- rent, lease or lend the software;
- · transfer the software or this agreement to any third party; or
- use the software for commercial software hosting services.

### 4. Orders and Authorized Users

Individual Orders (proof of purchase) specify your authorized scope of use for the Products, which may include: (a) number and type of Authorized Users, (b) numbers of licenses, copies or instances (for

Software), or (c) other restrictions or billable units (e.g. square meter count of managed space). The term "Order" also includes any applicable Product or Support and Maintenance renewal.

[Reseller Orders] This Agreement applies whether you purchase our Products directly from *HyperHouse Technology AB* or through authorized resellers.

[Authorized Users] Only the specific individuals for whom you have paid the required fees and whom you designate through the applicable Product ("Authorized Users") may access and use the Products. Authorized Users maybe you or your Affiliates' employees, representatives, consultants, contractors, agents, or other third parties who are acting for your benefit or on your behalf.

## 5. Number of Software Instances

Unless otherwise specified in your Order, for each Software license that you purchase, you may install one production instance of the Software on systems owned or operated by you (or your third-party service providers so long as you remain responsible for their compliance with the terms and conditions of this Agreement). We also make available "EVALUATION" licenses free of charge that allow you to deploy non-production instances, such as for staging or QA purposes.

# 6. Copyright and Intellectual Property Rights

The Licensed Software and all rights, without limitation including proprietary rights therein, are owned by *HyperHouse Technology AB*.

hdc.cloud, bim.cloud, tessel.se, tessel.com, tessel.pl - are domain names registered by *HyperHouse Technology AB* and are used to provide SERVICES

Customer will not allow third parties under its control to: copy, modify, create a derivative work of, reverse engineer, decompile, translate, disassemble, or otherwise attempt to extract any or all of the source code of the SERVICES and SOFTWARE.

The title and ownership of this SOFTWARE and SERVICES is retained by *HyperHouse Technology AB*. The SOFTWARE, SERVICES and its documentation are copyrighted and may not be copied, modified, merged or otherwise included with other products, with the exception of user customizations described in the SOFTWARE or SERVICE documentation.

The SOFTWARE may not be distributed, modified, reverse engineered, or used to create derivative works; the SOFTWARE, and any rights granted by License or Service use rights, may not be transferred to anyone without the prior written consent of *HyperHouse Technology AB*.

#### 7. Term and Termination

This Agreement shall remain in effect until terminated by you or HyperHouse Technology AB.

This Agreement will terminate immediately, without prior notice from HyperHouse Technology AB, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Application and all copies thereof from your: mobile device, desktop and/or server.

Upon termination of this Agreement, you shall cease all use of the Application and delete all copies of the Application.

# 8. Severability

If any provision of this Agreement is held to be unenforceable or invalid, such provision will be changed and interpreted to accomplish the objectives of such provision to the greatest extent possible under applicable law and the remaining provisions will continue in full force and effect.

# 9. API Usage

HyperHouse Technology AB grants limited, revocable, non-exclusive and non-transferable license to Customer or its integration partner to develop solutions against software API according to purchased license (see #3 Orders and Authorized Users).
